### **II. Course Description**

This course examines the social, cultural, economic, and political development of what became the United States from sixteenth-century European colonization through the Civil War and Reconstruction. Viewing American history in an Atlantic context, this course emphasizes the relationship between native peoples and European settlers, the origins, character, and evolution of chattel slavery, and the role of religion, technology, war, and capitalism in shaping American society. Understanding these crucial themes will reveal how the world we live in today came to be.

The course readings can be found in the textbook *Give Me Liberty!* (Eric Foner) and in an accompanying collection of primary sources in *Voices of Freedom* (Eric Foner).

## **III. Learning Outcomes**

By the end of the course, you will be able to:

- 1. Identify the key events and themes in American history from 1607 to 1877.
- 2. Appreciate the ways in which the interaction of diverse peoples from three continents influenced the development of American culture, politics, and society.
- 3. Understand the ways in which the early American past shapes the world we live in today.

- 4. Analyze and contextualize historical evidence.
- 5. Articulate claims about the past in the form of thesis statements.
- 6. Write clearly and persuasively.

## V. Course Requirements

#### Lectures:

In this online course, I will deliver course content through lectures. These lectures and PowerPoint presentations will be uploaded to Brightspace daily. I expect you to watch the lectures and take thorough notes. Readings from the Textbook *Give me Liberty!* are supplementary.

## Participation: "Source Responses"

In addition to watching the lectures, I expect you to complete the "Source Response" on Brightspace by 5pm its due date. What is the "Source Response" you say? You will read one of the primary sources in *Voices of Freedom* and produce a one paragraph written response to a question I provide in Brightspace. You will upload your response. Each response will be graded out of 10 points. All your responses combined will be worth 10% of your final grade. You can miss one "Source Response" without any penalty, just let me know which week you plan to miss.

#### Major Term Assignments:

In addition to completing the "Source Response" weekly, you will also complete two short papers, a midterm exam, and a final exam. For your papers, you will compose clearly organized and argued responses to the broad questions below. A grading rubric is available on Brightspace.

FIRST SHORT PAPER (3-4 pages). **DUE: Wednesday, 10/28** by 5pm via Brightspace.

How did the Indigenous Peoples of North America respond to European colonization?

SECOND SHORT PAPER (3-4 pages). **DUE: Wednesday, 12/2** by 5pm via Brightspace.

How did the institution of chattel slavery shape the development of the American Republic from 1783 to 1860?

EXAMS: We will have a midterm and final exam. These exams will be conducted online through Brightspace. Because these are open-book exams, they do not require memorization or the simple regurgitation of facts. Instead, you will write an essay in response to a prompt. You will use evidence from the lectures and readings (facts) to support a thesis (interpretation) in response to a question (problem).

#### Attendance Policy:

## The Final will take place during the scheduled Exam Week.
